# **Drug and Alcohol Misuse and Mortality Dashboard**




- Highlights OC Drug & Alcohol Trends from 2010 through

#### 2010-2012 Drug & Alcohol Mortality Rates




#### 2019-2021 Drug & Alcohol Mortality Rates




# **Drug and Misuse and Mortality Dashboard**

# **Community Narcan Education and Prevention**



- In partnership with the Hazelden Betty Ford Foundation, HCA provides overdose prevention education and training on the use of naloxone to the community
- All HCA Mental Health and SUD clinical staff are trained and able to distribute naloxone
- Naloxone training available throughout the Mental Health & Recovery Services system of care, including county-contracted providers
- HCA expanded participation in the state Naloxone Distribution Project (NDP)
  - Available at all Adult & Older Adult and Children, Youth & Prevention programs,
  - Outreach & Engagement (O&E) Team
  - SUD outpatient and residential treatment providers, including recovery residences

# **Increasing Access to MAT and SUD Treatment Services**

#### **Access:**

- OC Links 24/7/365 Access Line provides warm link to SUD County clinics during business hours
- Beneficiary Access Line 24/7/365 days and able to schedule throughout the Drug Medi-Cal Organized Delivery System (DMC-ODS) for an initial assessment to determine the most appropriate level of care
- O&E, Centralized Assessment Team (CAT), County MH Clinics and Open Access, AB109 Screeners and CSU staff can directly refer and schedule an initial assessment

# **Increasing Access to MAT and SUD Treatment Services**

#### **Access:**

- HCA staff coordinating care with Correctional Health Services (CHS) to link individuals to an outpatient SUD provider, including MAT services. This is to ensure that individuals who were receiving SUD/MAT receive seamless care upon release
  - This includes in-reach and transportation support
- 'In-Custody SUD Treatment' program provides SUD treatment including group, individual and case management services while in custody; helps with linkage to outpatient or residential treatment services after discharge
- Peer Mentoring Program assist with supportive services to ensure successful linkage to SUD treatment and other community-based programs
- Additional MAT providers
  - Santa Ana SUD Clinic
  - County-Contracted Providers

# **Supports for Pregnant/Parenting Women and heir Families**

Federal Comprehensive Addiction and Recovery Act (CARA) of 2016 requires States to implement **Plans of Safe Care** (**POSC**) for infants "affected by substance use"

### The Goal of Plans of Safe Care is to ensure:

- Maintain a substance-affected infant in the home safely
- If child is detained, allow for reunification as quickly as possible
- Connect the infant, mother and family with the services and supports
- Provide an opportunity for systems coordination to support families affected by SUD's

# **Current Activities supporting POSC Implementation:**

- A robust Family Treatment Task Force has been working on planning and related-activities to support POSC implementation in Orange County
- OC awarded grant to participate in the 2023 Policy
   Academy for advancing Collaborative Practice and
   Policy: Promoting Healthy Development and Family
   Recovery with a core workgroup with representation
   from the Courts, SSA, hospitals, CalOptima and HCA

# **OC Opioid Abatement Settlement Plan Proposal**

- OC is scheduled to receive \$3.3 million for the Nationwide
   Settlement of Claims Against Opioid Distributers annually for
   18 years, including funding from 16 cities that have reallocated
   their funds to the County.
- MHRS has put together a proposed plan with four strategies, based on evidenced based practices that are standards of care when it comes to addressing Opioid Use Disorder and prevention

# OC Opioid Abatement Settlement Plan Proposal

# 1. Addressing the Needs of Criminal Justice-Involved Persons:

 Fund MAT to individuals with Opioid Use Disorder who are incarcerated and offer support recovery support via transition to continued MAT upon release along with harm reduction supports

# 2. Addressing the Needs of Pregnant or parenting Women and Their Families including Babies with Neonatal Abstinence Syndrome(NAS)

 Fund Coordinators for perinatal services and supports to work directly with referrals received from Maternity Wards in OC to help coordinate POSC supports for Opioid Use Disordered (OUD) mothers and Opioid affected babies

# **OC Opioid Abatement Settlement Plan Proposal**

## 3. Prevent Misuse of Opioids

 Support efforts to prevent the misuse of opioids through evidence based/ informed strategies specific to Adults and Youth by leveraging and adding to the current SUD prevention campaigns

### 4. Prevent Overdose Deaths and Other Harm Reduction

- Training and education regarding Narcan for community
- Purchase Overdose prevention kits that include Narcan and Fentanyl test strips
- Provide distribution of free overdose prevention kits through community coalitions
