Presentation:

Chorus: Digital Close Loop Referral System By: Sharon Ishikawa, Timothy Sigafoos, and Thai Nguyen

Sharon Ishikawa provided the need for the development of the Universal Referral Portal. Sharon provided the context for the need for a new system, highlighting changes in policy and need over the past few decades. As a result, processes and procedures that may have worked in the past have become outdated or inefficient. Since 2021, Sharon and her team have been working on OC Navigator and other applications to integrate and connect the various programs and services provided by BHS through Chorus, thus reducing repeated data entry. In 2023, a crisis system of care referral closed loop referral system was launched and in 2024, going into this year, the team has been designing and are working and testing to launch the Universal Referral Portal.

Timothy Sigafoos presented on the Universal Referral Portal. The vision of the portal is to create a fully integrated and responsive behavioral health network for eligible OC residents to obtain timely access to coordinated, personalized care, resulting in improved overall health outcomes and an enhanced quality of life. The portal will allow the system to have a way of moving client and their data through the systems for internal and external programs. The team has been working with Children and Youth Services, Adult and Older Adult Mental Health, Quality Management Services, Data Analytics and Evaluation, the 24/7 Medi-Cal Access Line, and CalOptima to pilot the system and provide feedback to improve the efficiency for clients and staff interacting with the system. Chorus has also provided their feedback to improve processes.

Thai Nguyen demonstrated a beta version of the system, going through a process of setting up a client, documenting referrals, screening tools, and how the system is used by different parties that may be accessing records.

Sharon's team to get back to the board regarding how the integration of a client who is under Medicare will be managed in the system. Board also requested to see information on the top searches in OC Navigator.

BHS Chief's Report

Annette Mugrditchian provided an update on the payment reform fee for service, which is set to be implemented July 1, 2025. Annette also informed the Board that BHS will no longer be working with the Nami warmline. Alternative lines available which are CalHope and California Warm Line, which will be updated to OC Navigator. Linda requested an update on the list of programs that will be terminated due to BHSA. Michelle Smith is currently working on a list to be presented to the Board of Supervisors as well as BHAB. Linda also requested a 25-26 Budget showing programs that will be funded and what amounts they anticipate the funding will be. Regarding the Irvine Campus Update for Be Well, plans to build will be moving forward. More updates will be released soon.
